## Dear Campus Animal Users,

As this semester draws to a close, we wanted to highlight two recent issues--one here at UCB and the other at UCSF--that are relevant to animal research on campus.

At the recent AAALAC site visit exit meeting, the AAALAC team was very complimentary about our animal care and use program, the condition of our facilities, and our recently improved occupational health and safety program for people working with animals. The lead site visitor recommended that our program be formally re-accredited in January with exemplary status. This good preliminary news is thanks to your efforts, as well as the coordination with the ACUC, OACU, OLAC, Physical Plant staff, EH&S, and the Vice Chancellor for Research.

A recent article in the [San Francisco Chronicle](#) (November 25, 2012) emphasizes our need to work closely with you to facilitate research while protecting animal welfare. More specifically, this article emphasized the enhanced regulatory stance of the USDA, unlike AAALAC, routinely conducts unannounced site visits. According to the article, "David Sacks, a USDA spokesman...called the Animal Welfare Act a baseline and said institutions "have to follow protocols *to the letter.*" (*our emphasis*). As ACUC/OACU/OLAC adjusts to this new regulatory environment, we ask for both understanding and input from you on finding ways to meet this increased burden while maintaining our excellence in both research and teaching involving animals.

## Updates to the Website

The OACU recently updated the ACUC website. We added the webpage, "[Are You New to UC Berkeley?](#)" to guide new investigators that intend to use animal subjects in their research. A Quick Guide summarizing relevant offices, committees, programs, and available services on campus is also available at the bottom of the webpage.

Additionally, we reorganized the "[Policies and Guidelines](#)" webpage to make information more accessible. The ACUC/OACU also updated all of the existing policies and guidelines, and developed new guidance documents in consultation with OLAC. Some of the new documents include:

- Policies on:
  - Animal Care and Use Program
  - Testing Biologicals Used in Laboratory Rodents
  - Use of Non-Pharmaceutical Grade Compounds
  - Change in Animal Ownership
- Guidelines on:
  - Reporting Suspected Deficiencies in Animal Care or Treatment
  - Blood Collection Techniques and Limits
  - Dosing Techniques and Limits
  - Environmental Enrichment Plan
  - Justification of Animal Numbers
  - Literature Searches for Alternatives

To assist investigators when writing or revising the Animal Use Protocol, we developed two new guidelines: Justification of Animal Numbers and Literature Searches for Alternatives. For help with Attachment A, the "[Justification of Animal Numbers](#)" guideline outlines the scientific justification required by the ACUC and regulatory agencies for different types of studies as well as links to free statistical software/calculators/equations and published literature on statistical justification of animal numbers. The "[Literature Searches for Alternatives](#)" guideline will provide assistance with Attachments B and C. In addition to providing example searches/keywords and online resources that are specific to animal welfare, this document also provides instructions and helpful tips on how to do a literature search.
